



Technical Assistance: CDBG Neighborhood Revitalization Program

The <u>North Carolina Department of Commerce</u> recently announced \$10M in available grants under its Small Cities Community Development Block Grant Neighborhood Revitalization (CDBG-NR) program. Centralina can support small communities in developing and implementing applications for up to \$750k for housing, housingrelated activities and public facilities.

IDENTIFYING LIVABILITY PRINCIPLES

The CDBG-NR program supports three livability principles that help guide sustainability and resiliency. Centralina can assist with the identification of eligible projects that incorporate at least one of the following livability principles:



Promote Equitable, Affordable Housing: Expand location and energy-efficient housing choices for people of all ages, incomes, races and ethnicities to increase mobility and lower the combined cost of housing and transportation.



Support Existing Communities: Target federal funding toward existing communities – through strategies like transit-oriented, mixed-use development and land recycling – to increase community revitalization and the efficiency of public works investments and safeguard rural landscapes.



Value Communities and Neighborhoods: Enhance the unique characteristics of all communities by investing in health, safe and walkable neighborhoods – rural, urban or suburban.

ELIGIBILITY

All NC municipalities and counties are eligible to receive Small Cities CDBG funds, with the exception entitlement cities and HUD-designated urban counties.*

* The North Carolina entitlement cities in the Centralina region are listed as follows: Charlotte, Concord, Gastonia, Kannapolis and Salisbury. The ineligible Centralina counties include Mecklenburg and Union.
